#### Changes to Page 75 in the 2019-2020 EGSC Catalog

The purpose of this change is to correct errors that appear in the EGSC catalog regarding the number of credit hours and the Typical BA in Fire and Emergency Services Administration Schedule chart that appears in the catalog and is attached to the BA-FESA webpage.

On page 75 of the existing 2019-2020 EGSC catalog, there are three (3) corrections that need to be made:

- 1. On this page is a chart that shows a typical BA-FESA schedule. When the chart was created in the 2016, there was an omission of one three (3) credit hour elective in the Second Semester of the Senior Year schedule. This chart should be amended to show two (2) electives for the second semester senior year, for a total of 15 hours for that particular semester. This brings the total of hours for the degree to 60, which is consistent with the program details.
- In addition, this chart does not include an additional Required Elective course option that is available to students. FESA 3111 Fire Related Human Behavior was created subsequent to this chart's creation and was never added as an option in the Second Semester of the Senior Year.
- 3. On page 75 as well, just above the chart, there is an error in the number of hours for Additional Guided Electives. Presently, it is showing "12-13 hours". For consistency, this should be 12 hours. This change was recently made by governance, but this item was overlooked as a part of this change. This is a simple typographical correction.

Attached are three charts. Chart One is as it existed in the 2016 catalog, and Chart Two is as it exists today. I am also including a replacement Chart Three that is the corrected version. I have this electronically and can provide it to the proper individual(s) so that these changes can be reflected in the catalog and in the FESA webpage.
